## 2 – <u>TABLED ORDINANCE – TO AMEND SECTION 16-977: SUBDIVISIONS AND SINGLE-FAMILY DEVELOPMENT OF THE LOWELL MUNICIPAL CODE.</u>

It has become apparent to the City Council of Lowell that a need exists to amend Section 16-373: *Categories for Subdivisions and Procedure for Subdivision Approval*, in order to provide updated regulations to allow for lot splits of land less than one acre.

It has become apparent to the City Council that a need exists to amend Section 28-4 *Soliciting from Public Roadways or Sidewalks Prohibited* in the Lowell Municipal Code in accordance with state and federal laws. Councilman Schein and Councilman Stucki made a motion and second to strike #3 from the Agenda with intent of bringing it back on next month's agenda. After further discussion, the motion and second was withdrawn. A second motion was made to table Ordinance until next month's meeting in order to rewrite ordinance with language to give police a tool to use.

A need exists to amend Chapter 16: Land Development Code of the Lowell Municipal Code in order to establish regulations pertaining to flex space developments in the City of Lowell, Arkansas. The Planning Commission held a public hearing to receive and consider valuable input from the public on the proposed amendment. The Planning Commission voted to recommend the adoption of the amendment to Chapter 16: Land Development Code of the Lowell Municipal Code. The City Council approved the amendment while the rest and remainder of the Lowell Municipal Code not specifically amended remains in full force and effect.
