Dexter Vandergood, 312 Franklin Way, Realtor sign blocking view of E. Monroe. Implore council to put "no outlet signs up on Franklin and Valley Drive.

Anthony Madox: Safety, safety, safety! We walk and do not worry about traffic. Pulling out to go east is very difficult; people are pulling in more; no place to put in commercial business.

Dean Bitner: Considerate of councilmembers who looked at property. Rezone C-2 could be across the street from neighborhood. On Working days, active neighborhood and everyone is in the streets. Accidents on Monroe west and people shoot into neighborhoods. Split lot into two pieces and a house could be built on it. Please stipulate "no access on Franklin, 264 access only".

# 4. ORDINANCE TO ADDRESS THE KEEPING OF BEES WITHIN THE CITY LIMITS OF LOWELL AND TO PROTECT NEIGHBORING LANDOWNERS AND OTHER CITY OF LOWELL RESIDENTS FROM CONDITIONS RESULTING FROM THE KEEPING OF BEES WHICH INTERFERE WITH THE QUALITY OF LIFE AND ENJOYMENT OF THE AREAS IN AND AROUND THE HOMES OF THE RESIDENTS OF LOWELL AND FOR OTHER PURPOSES.

The keeping of bees within the city limits of the City of Lowell has been permitted without guidance or regulation for some years. Lowell staff have received numerous complaints of swarms of bees from the hives of persons within the city occupying the areas around their homes to such an extent that they were unable to be outside in their backyards. Sometimes the bees would fly into the homes at such numbers and frequency that they were unable to relax in their homes also. The Lowell Planning Commission held a public hearing, listened to affected neighbors, bee keeping enthusiasts, and the Lowell Planning Staff consulted with state association experts. The Lowell Planning Commission has recommended that the City Council adopt an ordinance which will place reasonable rules on the keeping of bees within the city limits of Lowell.
