# 1. AN ORDINANCE AMENDING CITY OF LOWELL MINIMUM STANDARD SPECIFICATIONS FOR ALL LOCAL STREETS TO REQUIRE A TWO-INCH (2") ASPHALTIC CONCRETE AND A TWO-INCH (2") BINDER COURSE FOR CERTAIN STREETS IN LOWELL ARKANSAS.

The council has been advised that it is in the best interests of the citizens of Lowell, and in order to best protect and preserve the city's street infrastructure, that the street standards be amended to require two-inches (2") of Asphaltic Concrete and a two-inch (2") binder course and that these requirements shall be

included in the City of Lowell Minimum Standard Specifications for Streets, including at Appendix B of the specifications.
