OLD BUSINESS:

1. ORDINANCE AMENDING THE CITY OF LOWELL CODE OF ORDINANCES, SECTION 16-59, BY REZONING CERTAIN LANDS FROM SINGLE FAMILY RESIDENTIAL 15,000 SQUARE FOOT LOTS (R-C) TO NEIGHBORHOOD SERICES (NS).

Ordinance was tabled at the July council meeting and by unanimous decision of the council this evening, it was moved to Old Business for discussion and action. At the July 9, 2019 Planning Commission meeting James Crabtree presented a plan to develop a wedding venue. He asked the 28 acres of property at Dogwood and Honeysuckle be rezoned from Residential to Commercial. The Planning Commissioners voted rezoning the property from Residential to Neighborhood Services.

Public Hearing: Open: 6:41pm Close: 7:08pm

Matthew Miller, Honeysuckle, was opposed to rezoning and he couldn't see the difference between commercial and neighborhood services. He listed the following concerns: safety, sewage options, terrain, existing utilities, environment and eco system.

Ray Saldivar, 800 Grandy Place, opposed rezoning based on increased noise.

Dave Johnson, 626 Tucker Place, just built a new home and didn't want the environment to change from the peaceful way it currently is. He cited increased traffic as a concern and the noise from the wedding venue.

Korin Moore lives next to the proposed wedding venue. She opposed rezone because the next thing they would want would be a liquor license and she wanted to keep her privacy and didn't want more noise.

Maureen Moore, 1100 Honeysuckle was opposed the rezone because the person presenting the project was not the owner of the property and he wasn't a resident of Lowell.

Bryan Lee, Martin Lane, one of three sellers of the property, explained the property was in probate and if it does not sell, it will be divided into three parts.

Trent Sullivan, 401 Goodman Place, has been in Lowell 12 years. He bought six acres close to this property two months ago. Any event will increase traffic and he was opposed to anything commercial.

James Crabtree defended his wedding venue plan, promising to landscape it and keep the project in such a manner that the neighbors wouldn't be hindered.

Ordinance failed due to lack of motion.

NEW BUSINESS:

1. ORDINANCE AMENDING THE CITY OF LOWELL CODE OF ORDINANCES, SECTION 16-59, BY REZONING CERTAIN LANDS FROM SINGLE FAMILY RESIDENTIAL (R-A) TO SINGLE FAMILY RESIDENTIAL 8,000 SQUARE FOOT LOTS (R-E).

Because of an oversight, this piece of property with a home on it was excluded from the previous rezone request to the Planning Commission on July 23, 2019. By including this piece of property at 803 Concord Street, the entire parcel can be developed as planned.
