## 1 – <u>ORDINANCE – REZONING CERTAIN LANDS FROM SUBURBAN NEIGHBORHOOD (R-1) AND URBAN THOROUGHFARE COMMERCIAL (C-2) TO URBAN NEIGHBORHOOD (R-3) IN THE CITY OF LOWELL, ARKANSAS.</u>

Taylor Lindley, Crafton Tull, requested changing zoning on Old Wire Road and Apple Blossom; Southcast corner is commercial and rest is R-3. Changing zoning would avoid variance request in the future and make it more flexible. A Public Hearing was held for the city of Lowell AR on August 1, 2022 to hear public comments regarding the rezoning of approximately 6.27 acres of Parcel #12-00265-051 from suburban neighborhood (R-1) to urban neighborhood (R-3) and 18.72 acres of Parcel #12-00618-050 from urban thoroughfare commercial (C-2) urban neighborhood (R-3) located at S. Old Wire Road, Lowell, AR. The City Council has reviewed the rezoning and determined that it would be in the best interest, and benefit of the citizens of Lowell to approve of the rezoning request.

# 2 – ORDINANCE TO REPEAL ORDINANCE NUMBER 1005 OF 2017 IN ORDER TO RESCIND THE EXISTING TWO PERCENT (2%) ADVERTISING AND PROMOTION TAX WITHIN THE CITY OF LOWELL AND TO PROVIDE FOR THE EXPENDITURE OF ALL FUNDS COLLECTED FROM THIS TAX PRIOR TO THE RESCISSION AND STRICT ADHERENCE TO STATE LAW AND FOR OTHER PURPOSES.

Council voted to rescind the A&P tax. Approximately \$600,000 remains in this account and the A&P will meet this month to decide how to spend the remaining funds.

## 3 - RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A COST SHARE AGREEMENT FOR THE PURPOSE OF SEWER IMPROVMENTS FOR THE CITY OF LOWELL, ARKANSAS

Riverwood Homes, LLC. And NWA LD, LLC intend to develop subdivisions for an anticipated total unit density of 507 residential units in the city of Lowell. It is necessary that improvements be made to the sanitary sewer system in order for the City to provide adequate sewer services to the developments and provide necessary capacity for future developments and sewer capacity needs. The developers proposed a Sewer Improvement Cost Share Agreement to facilitate and assist with the cost of such improvements.

Police Chief Kuth stated current ordinance works, but he would think about the new ordinance and comeback with his recommendations to the next council meeting.

Puppy Creek Update: Currently removing trees. Cox Cable is relocating utilities. Big Box culvert coming is September 12th; contractors' goal is to have work done by November.

Bellview & Hwy 264: Plan to put in a temporary signal. TACT approved amount and Lowell will do the design. Working with ARDOT and it is on their books to do construction in 2023.

Zion Drainage Project: Project completed.

Bloomington & Monroe: Full designed and ARDOT finalized for late summer/fall 2023.

Brookhaven – Center Point Park Overlay – overlay streets; waiting on bids by August 2023. Homes can connect to sewer system end of 2022.

Sabre Heights – Bids awarded; starting construction in August. First of next homes can connect to sewer system end of 2022.

Monroe Extension - Design contract needs to go to ARDOT.

Apple Blossom & 149-71B – Working with Developer to pay for Engineering.

Wendy's - Good progress on Independence Plaza.
